Good morning:

I thank each of you for your continued efforts dealing with the current health crisis, whether you are working at your office, from your truck or equipment, or telecommuting from your home. I also want to thank you for your understanding as we navigate our way through the current COVID-19 situation.

As we continue to deal with COVID-19, I have heard from many of you over the past few weeks at [dot.commissioner@alaska.gov](mailto:dot.commissioner@alaska.gov) with your comments, concerns and suggestions. We pay attention to all of those and we implement your suggestions where we can. Some feel that we should do more, such as shut our offices down until the pandemic passes, but that is not an option.

It is essential to keep the State of Alaska up and running and the importance of what we at DOT&PF do every day for the people of Alaska cannot be emphasized enough. At DOT&PF, even during these times of social distancing, we like to say, "We touch every Alaskan every day." We do, and I also believe at times like this, we must maintain a sense of humor. Your health and well-being is important to us. We are pulling out the stops to see that your work space is safe and have instructed our cleaners to increase their attention to detail. I am asking each of you to continue to practice the highest level of hygiene possible. Your cooperation and patience with all of this is greatly appreciated.

Deputy Commissioner Mary Siroky is assigned full-time to the rapidly changing news of COVID and is communicating daily with DOT Leadership on the latest information.

We're learning that telecommuting has its own set of challenges. I look forward to the day when life returns to a more normal state, we can cancel situational teleworking and are all back together in our workplace doing business face to face.
